Sub: Sale of AIDS awareness stamps in CBSE Schools for resource mobilization to rehabilitate child victims of HIV – reg.


Ref: Letter dated 06/02/2014 of Shri P V Abdul Wahab, Ex MP, Chairman, Global Kerala Initiative, "Keraleeyam".

This is in continuation to this office Circular No.CBSE/AFF/2013/09/573862 dated 19/6/2013.

The Board has been informed that Global Kerala Initiative-Keraleeyam is a major Charity organization in Kerala working for the rehabilitation of the neglected and orphan HIV Positive children in India. The CBSE vide circular referred to above permitted Keraleeyam to distribute AIDS awareness stamps worth Rs. 5/- only in the schools affiliated to CBSE in Kerala during the academic year ending 31st March 2014.

The Chairman, Keraleeyam has requested that the organization may be given permission to distribute stamps in the schools affiliated to CBSE in India purely on voluntary basis.

On the basis of the request of the Chairman of Global Kerala Initiative-Keraleeyam, the Principals of all the Schools affiliated to CBSE in India are requested to cooperate and participate in this noble endeavor by accepting the stamps which will be distributed to the schools by Keraleeyam. The collection period will be limited to end of the academic year i.e. March 2015 and the sale of stamps will be only through the Principals of the schools concerned. Detailed accounts regarding the printing, distribution and sale of stamps shall be subjected to audit of the Government of Kerala.
